

## **OFFICIAL RULES OF THE #IWANTFESTTIX ULTIMATE FLYAWAY SWEEPSTAKES**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**Eligibility:** The #IWantFestTix Ultimate Flyaway Sweepstakes ("Promotion") is open only to natural persons who are legal residents of the United States of America or Canada (except Quebec), who are at least eighteen (18) years of age at the time of entry. Promotion may only be entered from and in eligible jurisdictions. Promotion Entities, prize providers, and their respective parent, subsidiary and affiliate companies, employees, agents, and suppliers, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible to participate. In the event of a dispute as to the identity of an entrant, the authorized account holder of the account will be deemed to be the entrant. Administrator may request any potential winner to provide proof that such person is the winner. All potential winners are subject to verification before any prize will be awarded. Subject to all applicable, federal, state, and local laws and regulations. Void where prohibited. **Timing:** The Promotion period begins at 12:00 PM Pacific Time on April 8, 2015 and ends at 12:00 PM Pacific Time on May 5, 2015. Administrator's clock is the official time keeping device of the Promotion.

For all entries: Each participant is eligible to submit up to one (1) Promotion entry during the Promotion Period, regardless of method or combination of methods of entry or number of entries submitted. One (1) Grand Prize consisting of one (1) #IWantFestTix Ultimate Flyaway which includes two (2) general admission standing room only tickets to winner's choice of one Music Festival taking place in the United States and Canada prior to November 1, 2015; round-trip charter/value economy air transportation for two (2) from the major airport nearest Grand Prize Winner's home within the U.S. or Canada to a major airport nearest the festival location departing the day prior to the festival and returning the day after the festival, or five (5) days later, whichever comes first; one (1) double occupancy standard hotel room for up to four (4) nights / five (5) days; and a \$250 pre-paid cash card to use for ground transportation.
